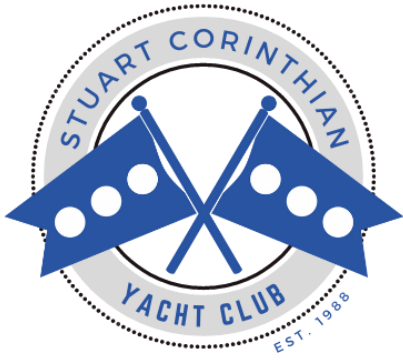

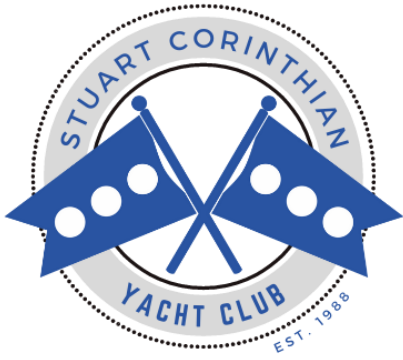

REGULAR MEMBERSHIP

- The required non-refundable Application Fee in the amount of \$100 plus tax.
- There is a one-time Initiation Fee in the amount of \$750 payable upon Board of Directors approval .
- Annual Dues which includes the Annual Operational fee for a total of \$2,740 per year or \$228.33 per month plus taxes.
- There is a food and beverage minimum spend of \$600 per bridge year and will be billed to your account on an annual basis.
- Should you obtain a boat slip in the SCYC Marina, there will be a one-time Dock Capitalization Fee of \$2,150.
- Regular Membership provides enjoyment of all benefits of the Club, including voting rights, the opportunity to hold office, chairing a committee and the priority use of a Club boat slip when available.
- I/We agree to conform to and be bound by SCYC Bylaws, the SCYC Code of Conduct, and all Rules and Regulations of the Club.
- Florida sales tax will be added to all dues, fees and purchases. I/We further understand that the above quoted fees are subject to change by the Board of Directors.

ALL APPLICANTS MUST SUBMIT THE FOLLOWING ITEMS:

- A complete membership application form
- A copy of their driver's license(s)
- Non-refundable application fee
- A biography of all applicants

Once all of the above has been submitted, the following process will take approximately 2-3 weeks. However, while you are awaiting your application to be reviewed, we encourage you to join us at the Club for Wednesday Happy Hour. In which case, a credit card must be placed on file to cover any of your food and beverage expenses during this timeframe.

1. Your biography will emailed to all members as well as it will be posted in the clubhouse for two weeks for membership to review.
2. Your application will be submitted to the Board of Directors for consideration. The Board meets on the 3rd Thursday of every month.
3. You will be informed of your acceptance by the Membership Chair.
4. Once you are accepted as a member, the one-time initiation fee will be due.
5. You will be formally introduced to the Club membership at a Wednesday Happy Hour where you will receive your permanent name tags and be given an SCYC goodie bag.
